By using Club Penguin Atake, you accept that we are completely separate from The Walt Disney Company and/or the Disney Interactive Media Group (collectively, "Disney"). We are an independent project. We do not have any contact with Disney. You agree to release Disney, as well as any of its employees or agents, from any liability, corporate, or personal loss caused as a consequence of the use of our services.

## Information you provide us

Club Penguin Atake obtains information about you primarily from data that you submit to our services.

- Information about you:  
By using Club Penguin Atake's services you submit data to create an account. You can read more about this process [here](#). The data provided by you is your email, Club Penguin Atake username and password. Your password is securely encrypted and is not visible to anyone, including our Staff. Club Penguin Atake only uses this data for account management and it is not shared with anyone else without further notice before.  
Google Analytics collects first-party cookies, data related to the device/browser, IP address (when collecting data, Google Analytics 4 does not log or store IP addresses), and on-site/app activities to measure and report statistics about user interactions on the websites and/or apps that use Google Analytics. We use Google Analytics to capture how you use and interact with our website through behavioral metrics, heatmaps, and session replay to improve and market our products/services.

We save correspondence data to better serve your needs. We make every effort to anonymize the data we acquire from you when you submit data via the app's forms. Anti-spam procedures, particularly on third-party forms or services, may capture your IP address.  
We actively gather information required from you when you use the features of our sign in and registration pages, primarily: a valid email address, penguin username and password. Your password is securely encrypted and is not visible to anyone, including our Staff. Both of the features we receive from these sites are used to keep the user account active.

## Data obtained from third parties

Club Penguin Atake collects first-party & third-party information from via our website and app analytics - Google Analytics.

We use Google Analytics to capture how you use and interact with our website through behavioral metrics, heatmaps, and session replay to improve and market our products/services. Website usage data is captured using first and third-party cookies and other tracking technologies to determine the popularity of products/services and online activity. Additionally, we use this information for site optimization, fraud/security purposes, and advertising.

Google Analytics collects first-party cookies, data related to the device/browser, IP address (when collecting data, Google Analytics 4 does not log or store IP

addresses), and on-site/app activities to measure and report statistics about user interactions on the websites and/or apps that use Google Analytics.

## Your Security Rights

# Your California Privacy Rights

This Club Penguin Atake Privacy Policy conditional section only applies to California residents.
